

### Scout Leader Sentenced in Sex Assaults

Gilford Boy Scout leader has received a deferred four-to- is deferred up to a year and he eight year prison sentence after pleading guilty to sexually assaulting three young boys last winter.

Höwever. Robert Litteer of Longridge Drive. Gilford. was ordered to begin a six-month sentence in the Belknap County House of Correction, Sept. 3, on one of the counts.

Litteer was indicted last January and February for the aggravated felonious sexual assault of one child; a felony; and five sexual assaults on other young boys; all misdemeanors. The children were aged seven. eight and 11, according to court records.

Judge William J. O'Neil said in a lengthy sentencing state- the probation department.

LACONIA - A 43-year-old ment, released yesterday, that Litteer's State Prison sentence may petition the court after July 6, 1986, for further deferral or suspension of the sen-

> "As this sentence is the result of a plea bargain, the terms of this disposition are final," O'Neil said in his ruling.

Neither party may seek a modification of the order, but the state may impose any suspended portion of the sentence upon proof that Litteer fails to comply with the ruling, O'Neil added.

Litteer was placed on probation for one year and ordered to pay restitution to the victim for psychological counseling in an amount to be determined by

Judge O'Neil said Litteer must participate in counseling for treatment of his psychological disorder with reports of treatment to be provided to the court.

He also must be treated for substance abuse and must completely refrain from use of alcohol or controlled drugs, O'Neil said.

Litteer must devote a minimum of 1,000 hours to a community service project with monthly reports of the progress to be provided to the court.

The project isn't to involve any association with minor children, according to the court order.

All contact with minors is forbidden and only Litteer's children are to be allowed into his residence or place of busiJanuary 17, 1985

I know you will keep us informed as more transpires. We would like to know, of course, the outcome of any legal precedings and sentencing that may take place.



Enclosed you will find a Confidential Record sheet on Robert Litteer of Laconia, New Hampshire, who has been Scoutmaster of Troop 243, chartered to the Gilford Community Church in Laconia since February of 1979. With it are newspaper clippings which show that he has been indicted on three counts of aggravated felonious sexual assault against seven and eight year old boys, none of whom, to our knowledge, are involved in Scouting.

Coincidentally, Mr. Litteer was arrested at the time that the unit was due to recharter, and so the chartered organization simply decided to replace him and no letter from the 3SA was delivered revoking his registration. Correspondence between Rev. Wixson, pastor of the church sponsoring the unit, and Jack Carr, our district Scout executive in that area, is also enclosed.

Obviously, Mr. Litteer is innocent until proven otherwise but we are alerting you to the situation at this time. Please let me know if there is anything further that you need at this time.





Per our phone conversation of January 3, 5:15 p.m., I am putting some of my remarks down on paper since we were both caught off-guard over the Robert Litteer situation.

I was contacted at 4:50 p.m., on January 3, by Mr. Edward Fitzgerald, the County Attorney of Belknap County of New Hampshire. He called to inform the Council that Mr. Robert Litteer, Scoutmaster of Troop 243, was arrested on the afternoon of January 3, after indictment by the Grand Jury on a charge of sexual abuse of two boys. He is being held at the Belknap County Jail until a bail nearing on the morning of Friday, January 4, 1985, at which time he will probably be released on bail.

Since the church is the sponsor of Troco 243, we need a letter from you as the executive officer of the sponsoring partner stating that you desire to make a change in the Scoutmaster leader for reasons of the church, and indicate whom you designate to assume the Scoutmaster position. We are fortunate that the current unit charter is presently in a lapsed status, because of a shortage of \$26.05 for rechartering purposes.

We stand ready and willing to assist you, the church and the Troop in any way possible. Please feel free to contact us at any time for assistance, information, or to answer any questions that you may have.

### Gilford Scout Leader Facing Sex Charges

GILFORD (UPI) - A local Boy Scout leader has been indicted on charges of sexually assaulting young boys, but the minister at the church sponsoring the troop said Saturday the alleged crimes are unconnected with the Scout program.

Robert Litteer, 43, of Gilford was indicted by a Belknap County Grand Jury last week on three counts of aggravated felonious sexual assault against 7- and 8-year-old boys. The offenses allegedly took place between February and December in 1984..

"The charges have nothing to do with the troop," said the

Rev. Raymond Wixson, minis-. ter at Gilford Community Church, which sponsors Troop 243. "I happen to know who brought the accusations and know they are in no way connected with the Scout program." ....

... Wixson pointed out that New Hampshire law requires that "anyone who's aware of anything along this line must report it. I assume if anyone was. aware of such wrongdoing as SCOUT LEADER Page 134

Wixson noted, however, Litteer has been asked to step down as leader of the "outstanding program he ran for five years with full registration most of the time.

'Mr. Litteer has: been relieved of his responsibilities of Scouting until his case is adjudicated. We assume he's innocent until proven otherwise. (but) we've done that in keeping with the national policy of the Boy Scouts of America," Wixson said.

"Whenever a member (of the Scouts) is indicted, the sponsoring institution relieves leaders until the case is adjudicated. We have designated an (interim) scoutmaster whose has been assistant scoutmaster, he said.

Litteer is a father of three teen-aged girls and formerly worked as a school bus driver and a law enforcement officer for the White Mountain National National Forest. Wixson said. For the last year and a half. Litteer has run a dog kennel with his wife.

### Four Are Indicted By Grand Jury For Sex Assaults

LACONIA — A Grand Jury returned 32 indictments, including two secret indictments, during a two-day session in Belknap County Superior Court here this week.

Judge Walter Murphy presided and County Attorney Edward Fitzgerald presented evidence for the state, asking indictments

be returned against the following:

Robert Litteer, 43, of Longridge Drive, Gilford, three counts of aggravated felonious sexual assault against seven and eight-year-old boys. The offenses allegedly took place on three occasions between February and December of 1984.

Paula M. Payer, 25, of Route 25, Meredith, aggravated feloni-

ous sexual assault on a three-year-old girl.

William E. Hallinan, 36, of 12 Winter St., Laconia, two counts of aggravated felonious sexual assault on a 15-year-old girl. The incidents allegedly occured in August and November of 1984.

Charles Carr, 27, of Somerville, Mass., kidnapping a 15-yearold girl in Boston last October, then confining her in an Alton cottage. is charged with felonious sexual assault and aggravated felonious sexual assault against the girl.

Mark F. Johnson, 24, address unknown, robbery of \$1,400 with a

handgun at the Park-N-Go Market in Tilton last Nov. 14.

Ralph Longo, 24, of 12 Mechanic St., Tilton, robbery with a semi-automatic pistol at the Tilton House of Pizza last Nov. 6 and burglary armed with a deadly weapon at the residence of Mary Jane Hansen on Burleigh Hill Road in Sanbornton.

Richard R. Blaney, 27, of Box 506, Narrows Road, Center Barnstead, four counts of burglaries at property owned by Paul Thibault, William Nescot, James Navarro and Earl Houghtaling, all

of Center Barnstead, last October.

Mark Greenwood, 18, of 91 Highland St., Laconia and Dennis Ward, 20, of Main Street, Laconia, both indicted for burglary at B. Mae Denny's restaurant in Gilford on Nov. 29. The pair was also indicted for theft by unauthorized taking involving a pavement breaker owned by JCR Construction valued in excess of \$1,000.

Dennis Bryson, 27, of Dearborn Street, Belmont, possession of a firearm, a .20 gauge shotgun, after having been convicted of a felony. Bryson was previously convicted of second degree assault in April, 1982.

Donna Connolly, 24, of Lake Street, Bristol, also known as Donna Catherine Babchyck and Donna C. Martin, indicted for welfare fraud in the amount of \$2,340. Connolly allegedly failed to divulge her marriage last January that altered her financial circumstances.

Gilbert Pidgeon, 22, of 121 Messer St., Apartment 5, Laconia, indicted for possession of a controlled drug, marijuana, after being previously convicted of a similar offense last April.


