### Murder count fil d against resident

Quadir Hakeem, 30, of 1923 Cumberland St., was charged with capital murder Friday night in the early morning shooting death of a Little Rock man, the police said.

Harry E. Magar. 68, of 3324 High St. was killed about 1:50 a.m. in the 2900 block of S. High Street. He was shot once in the chin during a robbery, the police said.

Sunday Stanfield, 30, of 3409 High St. told police Magar had driven her to the site of the shoot-

ing and he was waiting in his car ent to a nearby resiwhile sevent to a nearb dence to wake up a friend. while si

She told the police she heard a shot and returned to the car to find Magar dead, still sitting in his car.

The police said Magar was shot with a large caliber handgun. Detective Lt. Fred Hensley said Magar was probably shot with his own gun, a 32-caliber pistol, which was found in the car.

Detectives said Magar's wallet was missing. Investigators think two men were involved in the robbery and shooting.

Magar was a security guard at Summit House Apartments. His killing was the 40th homicide in Little Rock this year.

A federal jury Thursday ordered St. Francis County to pay \$15,000 to each of three former sheriff's employees on the grounds that their contracts were breached when they were fired.

Four former employees had contended that they were fired by St. Francis County Sheriff Dave Parkman when he took office Jan. 1, 1987, because they supported then Sheriff Coolidge Conlee. Parkman defeated Conice in the 1986 elec-

They said the county violated their employment contracts because the sheriff's office personnel manual wasn't followed in their dismissal.

U.S. District Judge G. Thomasi Eisele directed a verdict for the county and Parkman in the claim; of Otto Jones, a jailer.

The jury, after deliberating

nearly five hours, exonerated Parkman on the first amendment claim but awarded a total of \$48,000 to Pauline Daniels, a cook; Paul Denning, a jailer, and William "Sonny" Wise from the county.

J. Fletcher See III of Little Rock. attorney for the plaintiffs, told the jury in closing arguments that the purported reasons each of the deputies was dismissed were only excuses to cover up the real motivation - that they had supported Conlee.

Fletcher Long of Forrest City. attorney for the county, said Parkman had a right to fire anyone he believed guilty of wrongdoing and had believed wrongs had been committed by Jones, Daniels and Wing, Denning now lives in Sheridan. The others live in St. Francis

The fired employees asked for back pay and unspecified damages.

### Sexual abuse charged

Dewey Magar, 32, of 3324 High St., was arrested Thursday on two counts of first-degree sexual abuse of a 12-year-old boy.

The police said the incident occurred Dec. 12 in the 7800 block of Illinois Street, but wasn't reported

until Wednesday.

On Thursday, January 3, 1986, Magar was sentenced to six years in prison for sexual abuse of a 10-year-old boy. Enclosed is a copy of the news account. The judge told me that he would put into parole requirements a restriction to any association with Scouting in the future.

# LR man sentenced in sexual abuse case

Dewey E. Magar, 28, of 3324 High St., was sentenced Thursday in Pulaski County Circuit Court to six years in prison for the sexual abuse of a 10-year-old Little Rock boy.

Magar pleaded guilty Nov. 21, 1985, to the March 24, 1985, first-degree sexual abuse of the boy. Circuit Judge Floyd Lofton stipulated that Magar must serve at least one-third of his prison sentence before becoming eligible for parole.

### Judge orders election plans for Humnoke

U.S. District Judge George Howard Jr. gave attorneys 10 days to submit plans for an election process that gives all voters an equal say in school board elections for Rumnoks School District No. 5.

"I'm seeking to offer each patron the opportunity to participate in a fair election," he said during a hearing Thursday morning "Obviously we're not guaranteeing a black representative or a white representative, but we want to assure no patron's vote is diluted."

In October, Howard ordered the school district in Lonoke County, bordering Pulaski County, to end its unconstitutional racial practices, including "at-large" election of school board members. It was the state's first successful challenge of the method of selecting a school board of selecting a school board.

John. Walker, attorney, for three black parents who filed the lawsuit last year, proposed splitting the district into halves with roughly equal populations. The predominantly black community of Allport would be in one district, and Humnoke — about 80 percent white — would be in the other.

Walker also suggested maintaining a five-member board rather than going to a seven-member board as suggested by Ed Weaver, district superintendent. Weaver had no comment on Howard's suggestion that a transition could be arranged without disrupting the five-year terms of incumbent school board members by electing an Allport board member at each of the next two annual elections, then an at-large member, then two Humnoke officials

A 10-member biracial committee that includes five blacks was named Dec. 31 to work with the court and the school board in establishing non-discriminators, employment criteria and revising student disciplinary procedures.

#### SUMMARY

On 3-24-85 at approximately 0600 hours ...................... Dewey Magar, Henry Lee, and Forrest Wheeler were in the living room of Wheeler's residence at 1707 M. University waiting to throw newspaper route. Magar began "horsing around" whith the boys, tickling them and at one point was on the couch along with the day r held the in his lap and slipped his hands down seems parts. He put his hand into seems! underwear and began tickling seems senie and pulling on it. This continued for a couple of minutes befor Magar stooped and let we up. The boys and Magar threw the paper routes and spent the morning playing together. At approximately 1300 hours while playing with a ball in Forrest's backyard, Hagar hit and it are held with the ball. left walking to his father's house a lock away. Magar followed after and stopped him at the edge of the 's Father's yard. Magar was telling he was sorry and asked him not to tell his father about the tickling. Something to and went out to find out what was gring on. When We confronted and Magar, Magar walked off. At that time told his father what Magar had done to him that morning. Mr. 3000 then called the police. Officer M. S. Westbrook, Officer Larry Ringgold, and Officer Clifford Webb responsed to the call. while interviewing the states the officers observed Magar walking near 1707 N. University. Magar was taken into custody at that time. Magar was transported to the LRPO Detective? Division.

On 3-24-35 at 1455 hours Magar was advised of his miranda rights by Detective Gray LeMaster and Detective Clyde Supelman. At 1530-hours Magar was charged with sexual abuse, first degree, at Detective LeMaster.

### SUMMARY

On the evening of 3-24-84, following Magar's release from jail, he went back to the Wheeler residence. At the house at that time was Phyllis Wheeler, Forrest's mother and Blaine Lougin. Hagar had a conversation with Mrs. Wheeler and Suggin during which he committed having tickled beneath his belt and having a sexual "desire" for the conversation.

### INFORMATION

After reviewing the Air Force Office of Special Investigations file as provided by Special Agentt Ed Dill regarding Dewey Magar the following is a summary of that investigative report. This file was reviewed on 5-9-85 at the OSI Office at the Little Rock Air Force Sase.

On 7-10-32, while Magar was stationed at Blytheville Air Force Base, the security police or base were notified that the son of a Lt. Col. stationed at the base had been sexually molested by a serviceman, also stationed at the base. An investigation revealed that the 12 year old victim met Magar at a base swimming pool. Magar took the youth to his quarters and offered to give him a massage. While giving the youth a massage on his bed, Magar pulled the boy's shorts down. The boy got up and started to leave. Majar gave the boy his name and talephone number after which the boy left. The youth reported the incident the same day.

On 7-10-32, after the victim was interviewed, Magar was picked up and also interviewed by the security police. Magar admitted that the massaging incident took place and admitted that he became sexually aroused. But he told investigators that he quickly realized that what he was doing was wrong and he stopped. During this interview, Magar also admitted having had a homosexual affair with a young nephew approximately three years prior to that time.

On 7-12-32 a sexual molestation involving Magar and a male youth who attended church with Magar was reported to the Blytheville Police Department. The incident took place on 7-3-82 off base in Blyhteville in the home of a civilian. The incident involved Magar kissing the boy and rubbing the boy's penis. A warrant was sworn out by the boy's

father and Magar was arrested by the Blytheville Police Department on 7-13-82.

Magar subsequently underwent psychiatric evaluation at an Air Force facility. In September 1982, Magar was allowed to be discharged from the Air Force in lieu of a court martial. He received a less than honorable discharge. He was also barred from the Blytcheville Air Force Base.
