Suspended or denied registration for the following reasons:

Because he has been under investigation for a natural interest in younger boys.

The Council office received a phone call from Mr. Ewing's sister, [REDACTED] who lives in Portland, Oregon stating that both she and her brother, Robert, were abused as children, and that she had caught her brother several years ago having oral sex with a young boy six-year-old, when Robert was 16. She stated that as late as Thanksgiving, 1990 Robert was away from home with a 12-year-old boy. She is sure that boys are being molested, and she wants her brother out of Scouting.

We reported this information to the District Attorney's investigator who also talked to Billie Williams, and began an investigation. At this date, there has been no legal action brought against him. The investigator states he has no reason not to believe what the sister has said.
